Sub : Passing of Resolution (Item No.1 & 3) through electronic AND poll conduct at the 59th AGM of CAPEXIL held on 18th September, 2017

The Members of Committee of Administration at its meeting held on June 29, 2017 had appointed me as Scrutinizer for the e-voting held between September 14, 2017 (9.00 a.m.) to September 17, 2017 (5.00 p.m.) and for the poll held at the 59th AGM of the Council on September 18, 2017
